



# **NOTICE OF RACE**

**LAKE MONROE SAILING ASSOCIATION**

## **Sanford SAILFEST REGATTA**

**(Formerly know as the Kettle Cup and Santa Sailfest)**

**DECEMBER 8 AND 9, 2018 SANFORD, FLORIDA**

### **VENUE**

- The regatta shall be hosted by the organizing authority, which is the Lake Monroe Sailing Association on Lake Monroe in Sanford, Florida.
- Regatta organizing headquarters is located at the LMSA Clubhouse, 531 N. Palmetto Ave, Sanford FL 32771.
- The number of races for this event will be governed by weather conditions and time.
- One completed race is required to constitute a regatta.

### **RULES**

The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).

### **ELIGIIBILITY AND ENTRY**

- The regatta is open to all seaworthy sailboats with a Portsmouth D-PN.
- Eligible boats may enter by completing the online registration at Regatta Network (<http://regattanetwork.com/>) or by submitting a hard copy registration form.
- All registrations must be accompanied with payment to be considered valid.
- All participants will be required to sign the *Lake Monroe Sailing Association, Inc. Release of Liability and Authorization Agreement*, to be eligible to race.

32772> Hard copy registrations must be received by LMSA on or before midnight December 1<sup>st</sup>, 2018 to qualify for early registration.

### **CLASSES**

- Five entries of the same model will be required for a designated One-Design class.
- One-Design classes may include Precision 23, Optimist, Catalina 22, Sunfish, Lightning, San Juan 21, Windmill, Hobie Wave, Raider, Flying Scott, Thistle, and others.
- One Design classes will be determined by number of early registration entries.
- All others will be assigned to Portsmouth rated classes based on ratings and vessel type.

### **REGISTRATION**

- Early registration closes at midnight December 1, 2018.  
*Registration and payment must be received on or before the deadline otherwise late fees apply.*
- Early Entrance Fee\* \$75.00
- US Sailing Membership -\$ 5.00 discount
- ***NO refund of event fees will be issued for this regatta.***
- Registrations and payments received after December 1<sup>st</sup> will be subject to a \$25 late fee.
- Online registration will close at midnight, December 6, 2018.
- Registration includes one Dinner ticket for Saturday evening.
  - *Additional Dinner tickets can be purchased during registration for \$15 ea.*
  - *Additional Dinner tickets will be subject to availability during late registration.*

### **PRIZES**

Trophies will be awarded to the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place finishers of each class.

### **SCHEDULE**

- Late Walk-up Registration will be available from 8:00 to 10:15 on December 8th, 2018 at the LMSA clubhouse.
- Skippers meeting to be held at 10:30am on December 8th, 2018 at the LMSA clubhouse.
- First Warning signal on December 8th, 2018 will be no earlier than 11:55.
- First warning signal on Sunday at 9:55.
- No series of starts will begin after 14:00 on Sunday.

### **SAILING INSTRUCTIONS**

The Sailing Instructions will be available before 11:00 on December 8th, 2018 at the LMSA clubhouse.

**COURSES**

Courses will be contained in the Sailing Instructions. Courses will be windward-leeward and/or triangle with drop marks.

**SCORING**

Appendix A is modified so that no race scores will be excluded.

**BERTHING**

Slips may be available at Monroe Harbor Marina.
